Terms and Conditions

1. Rest Alive LLC. is offering a Florida retreat from Friday, October 18th through Sunday, October 20th 2019. All participants must be 21 years or older to accompany Rest Alive LLC. and its members.

2. The total cost of \$325.00 plus tax is due prior to departure. Flights to and from Florida, must be purchased separately and it is the sole responsibility of the person(s) attending this retreat. The \$325.00 fee plus tax can be paid via credit/debit card at www.RestAliveLLC.com. Space is very limited for this retreat and it is recommended to book flight and suite stay as soon as possible.

3. The \$325.00 plus tax covers the cost of a two night, three day stay in a Presidential Suite at a luxury resort in Florida. Transportation from the Fort Lauderdale airport (as long as party is arriving on Friday, October 18th prior to 3pm), transportation to and from dining experiences, transportation to and from shopping experiences, and transportation to and from planned excursions. Departure times will be provided for each activity. Should persons decide to separate from the group, transportation back to the resort will be that persons responsibility. Should flights be delayed upon arrival, parties are expected to access and utilize transportation services provided by the Fort Lauderdale airport. The \$325.00 costs also covers catered hors d'ouvers and dinner on Friday, October 18th and breakfast on Sunday, October 20th 2019. Housekeeping services are included in this fee as well.

4. Rest Alive LLC. has the right to revoke any application or person from attending this retreat due to illegal activity such as crimes, violent behavior, or other means. Persons attending this retreat must conduct themselves according to the laws of Florida and maintain a behavior that is consistent with the peacefulness of this retreat. Should persons become violent, belligerent, or exude a repulsive manner that conflicts with the nature of this retreat, they may be dismissed from the Rest Alive LLC. retreat and will lose all monies paid towards the retreat as no refunds will be issued.

5. Rest Alive LLC. is not responsible for any loss, damage, or theft of personal items. Persons participating in this Rest Alive LLC. event waives all rights to hold Rest Alive LLC. and its members responsible for any loss both physical and personal. All actions will be completed to lock doors to vehicle and resort and it is the individual's responsibility to do the same in keeping

up with personal items. Participants are responsible for following the rules and safety rules of the resort, restaurants, and other attending businesses. Should persons trip, fall, or injure themselves at any time during this retreat, Rest Alive LLC. shall not be held responsible. All attendees are expected to have their own medical and dental insurance to cover any needs during this retreat.
